Fentanyl Task Force

Discussion	Oregon House Bill 2645 "re-criminalizes" fentanyl use by increasing penalties for possession of certain amounts. This is a reversal of a portion of Measure 110 in 2021, which decriminalized most unlawful possession of a controlled substance offenses.		

In January 2023, the Oregon Health Authority provided funding to 16 local public health authorities (LPHAs) to implement fentanyl-related education and media campaigns. LPHAs were selected for funding based on overdose burden and campaign bandwidth. Linn County Alcohol and Drug Program received \$5,000. The funds were used to develop and print Fentanyl Conversation Card sets parents can use to discuss facts about fentanyl with their teens. Linn Together has additional funds, up to \$10,000, available to build on this strategy. The funds may not be used for harm reduction strategies. The Linn Together Fentanyl Task Force has been formed to discuss possible strategies and collaborations to utilize the funds. The Linn Together Fentanyl Task Force had an initial meeting on July 7, 2023. Additional members are welcome to attend the next meeting, which will be a two-hour planning meeting on August 1 from 10:00-12:00 pm at the Armory Building in Albany. Volunteers are needed to assemble packs of Fentanyl Conversation Cards. Materials are available to take home today and assemble cards at home. Responsible Sales Training Presenter Danette Discussion Linn Together and Linn County Alcohol and Drug are hosting a Responsible Sales Training on July 26 from 1:00 to 3:30 pm at the Armory Building in Albany. Linn County Alcohol, tobacco and marijuana retailers and service establishments have been invited to the training. The training will provide employees with ID-checking tips and practice, along with the latest information on selling agerestricted products. Representatives from the Oregon Liquor and Cannabis Commission, Linn County Public Health, and Oregon Health Authority Problem Gambling Services will be giving presentations. There will also be a presentation about Linn Together's Bottle Tagging campaign. To date, 20 individuals have registered for the training. **Agency Updates** 

CASA of Linn County: On July 25 at 3:45 pm, two new CASA's will be sworn in at the Linn County Courthouse. The public is invited to attend. CASA is currently gathering donations for school supplies to be distributed to clients in need. Any additional supplies will be distributed to local community organizations. Supplies can be dropped off at CASA at 2730 Pacific Blvd in Albany or call 541-926-2651.

Parenting Success Network & LBCC Parenting Education: Mike reported that the "Dads at the Margin" group is developing a family night in collaboration with other local organizations. LBCC's Parenting Education program is receiving more requests for in-person parenting workshops and fewer for virtual workshops.

Eastside Christian Church: Ben shared that there will be a "Worship in the Park" event at the Mid-Willamette Valley YMCA on August 11 from 5:00 – 9:30 pm.

Aliza Tuttle: Aliza is participating in a Portland State University panel investigating the intersection between suicide risk and substance use. Aliza has a contact at the Albany Public Library that can help distribute youth marijuana prevention campaign and other Linn Together materials.
