Linn Together Updates & Approval of Minutes

Linn Together meeting minutes from December 13, 2023 were approved.

Brandi gave an update on pending changes to Oregon Measure 110, the 2020 law which decriminalized possession of small amounts of hard drugs. Measure 110 does not appear to be successful in reducing drug overdoses in Oregon. It is likely that in the 2025 legislative sessions changes will be made to make possession of these drugs a misdemeanor.
