	In Albany, children must eat lunch on-site, and there were fewer participants (7-30) per lunch at each school.
	Promotional bags were also distributed at the Albany Boys & Girls Club, YMCA, and Jackson Street Youth Services.

Discussion	Two STAND Youth Council members joined Ashley and Shannon for the CADCA Mid-Year Training Institute July 20-24 in Nashville, Tennessee.
